ABOUT THE FUND

The Lakehouse Global Growth Fund focuses on investing in mid- to large-capitalisation growth companies located mainly in developed markets. The Fund is invested in some of the world's largest growth companies using its signature long-term, high-conviction approach with a core focus on asymmetric outcomes.

INVESTMENT OBJECTIVE

The Fund's investment objective is to provide long-term capital growth and to outperform the MSCI All Country World Index Net Total Returns in AUD over rolling five-year periods (after fees and expenses but before taxes).

INVESTMENT STRATEGY

Lakehouse Capital's strategy for the Fund is to invest the majority of assets in a high conviction portfolio of typically 20 to 40 companies with expected long-term growth.

Our stringent investment process leads us to invest in companies that present the following characteristics:

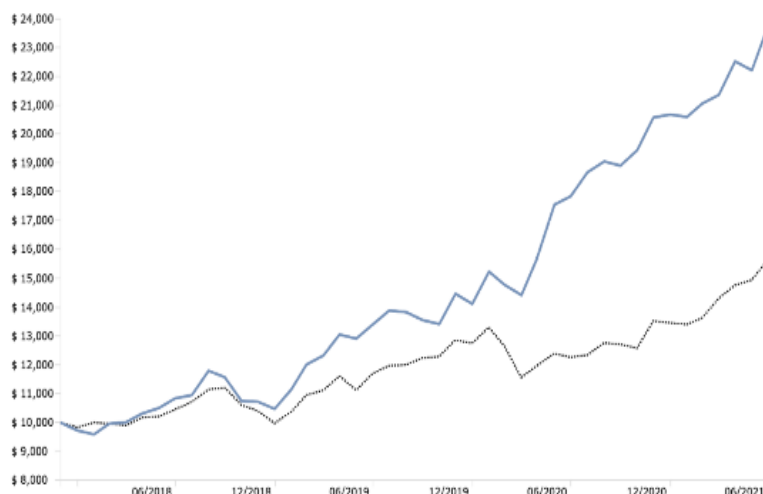
- Strong positions in growing markets.
- Pricing power with customers and suppliers.
- Durable competitive advantages grounded in: scale, strong brands, network effects, or high customer switching costs.
- Aligned and experienced management teams with strong track records of capital allocation.
- Conservative balance sheets.
- Attractive valuations.

PERFORMANCE REVIEW & COMMENTARY

The Fund returned 6.9% net of fees and expenses for the month compared to 4.5% for its benchmark.

The biggest contributor to performance during the month was **Sansan** (+20.57%), which was up due to strong market traction in its new service, Bill One, along with rising optimism of an eventual reopening of the economy. The largest detractor to performance was **Games Workshop** (-4.33%), which declined as the market rotated back into high-growth names and investor interest gravitated toward long-duration equities. There was no company-specific news during the month. The Fund's largest sector allocations at month end were to information technology (35.5%), communication services (24.0%) and consumer discretionary (19.0%). The Fund's position is larger than the benchmark in all three sectors and we expect that will consistently be the case over time as we view these sectors, or at least subsets of them, as having superior economics and long-term prospects. 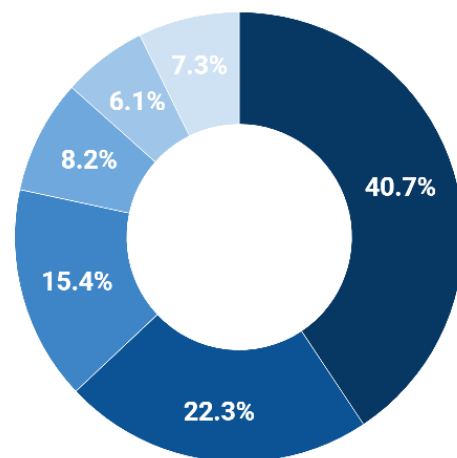
